INCOME INFORMATION

Must be handed in:-

Before the child is placed in child-care

- after request from the city
- always and immediately when the families income changes
- by request about temporary reduction of the fee

Changes of income during periods shorter than 1 month do not affect the fee.

Given income information is controlled if needed by the local tax authority. Wrongly stated income or neglecting to leave information about income changes means that correct fee will be calculated retroactively.

If information is not turned in resulting in the fee not being calculated, the highest fee from the tax system will be charged.

Parents/Guardians are obligated to report changes that affect the fee and to make sure that the correct fee is paid so that charges afterwards are avoided.

FEE-CALCULATIONS

Takes place with consideration of the family's income and number of children in the family. Calculations is based on the families total income (brutto), i.e. income before tax.

For couples who live together, with no common children, the fee will be calculated based on the parent's brutto income plus a legitimate amount that the board of the kommun sets annually.

OTHER INCOMES

THE BASE INCOME ALSO INCLUDED:

- sickness benefit/parental allowance (brutto)
- support for activity (brutto)
- cash labour market support (KAS)
- life interest
- governmental study allowance, special study allowance, special adult study allowance
- fee for care of child in foster home
- family contribution in forms of family allowance/daily allowance
- temporary disability pension

THE FOLLOWING CONTRIBUTIONS DO NOT BELONG TO BASE INCOME.

- maintenance

- study grant
- general child allowance
- governmental study grant in forms of prolonged child allowance and student aid
- disability allowance
- housing allowance

From the (avgiftsgrundade) income may the maintenance be deducted as shall be paid according to agreement or verdict.

Reduced fee or liberation from the fee can be granted under special circumstances. If this is the case, applications is made with the processor.

FEE FOR CHILD-CARE

Is the same amount every month, even if the child is absent.

The fee is paid every month of the year.

FEE CALCULATIONS IS THE FOLLOWING:

Fee for children in pre-school:

Child nr 1: 3 % av the income – yet no more than 1260 kr/mon

Child nr 2: 2 % of the income – yet no more than 840 kr/mon

Child nr3: 1 % of the income – yet no more than 429 kr/mon

Fee for children in school:

Child nr 1: 2 % of the income – yet no more than 840 kr/mon

Child nr 2: 1 % of the income – yet no more than 420 kr/mon

Child 3: 1 % of the income – yet no more than 420 kr/mon

child nr 4: no fee

The children of the household is added to get the first, second and third child. The youngest child is considered as the first child.

RESIGNATION

From child care must be made in writing as soon as the position is no longer needed. During the resignation that is 1 months, fee is paid.

CANCELLATION

(Kommunen) has the right to cancel the place if the fee is not paid, even though a reminder has been given. A new place within child care ca not be assigned if a former debt remains.
